State law requires that the tax on storage charges accrued against vehicles in storage be collected. This tax will be added to the bid at the public sale. If the bid is lower than charges owed to the wrecker Company, then the tow charge is subtracted from the bid and the remainder will be taxed. If the bid is higher or equal to charges owed to the wrecker company, then only the original storage charges will be taxed. The following table is a **maximum** approximation only.
